## 2023 KEY EXCHANGE MEETINGS SCHEDULED

Locks and lock combinations will be changed late afternoon on Thursday, January 26, 2023, so your current keys for the main entrance gate, the RV Storage lot, and the Boat Ramp will **no longer function** as of **Friday**, **January 27, 2023**.

Similarly, the lock combinations to the walk-in gate, basketball & tennis courts, and playground, will also be changed at that time, so the current 2022 combination will no longer function beginning January 27, 2023.

*If you currently have a key to the RV Storage or Boat Ramp*, and you plan to renew your SSHA membership AND your Boat and/or Storage Lot Membership(s), you will need to attend one of the two KEY EXCHANGE meetings scheduled for that purpose (see dates below).

You must bring your current key in order to exchange it for a new key at no charge. If you lost your key, per the rule sheet, the fee for a new key is \$100 because of the special cut that these keys must have for security reasons.

\*If you miss one of the two meetings above, you can exchange your key in the half-hour prior to the February SSHA Board meeting on Tuesday Feb. 21, 2023 (6:30-7:00pm), and the half-hour prior to the March SSHA Board meeting on Tuesday, March 21, 2023 (6:30-7:00pm). Keep in mind that your current key will not be valid after Friday January 27, so please plan accordingly.

If your current Boat/Storage Membership form on file (your address, boat/RV/trailer manufacturer, length, license plate number, insurance, etc.) had no changes to your information in 2022, then you will not have to complete a new form for 2023.

If ANY of your information changed in 2022 about you or your boat/RV/trailer, then you must complete a new Boat and/or Storage Lot Membership Form (PDFs attached — or find them on the SSHA website). Complete and print 2 copies, and bring your completed forms and new boat/RV trailer information with you to one of the above meetings.

Remember: all Boat and Storage Lot members **must show proof of liability insurance on their Boat/RV** at a Key Exchange meeting before a new key can be issued. Note: At this time, the annual SSHA dues, Boat Club and Storage Club Membership fees have not been established for 2023. Annual dues and fees will be discussed and voted on at the **Annual SSHA Member meeting on Sunday January 22, 2023 (3-5pm)** held at the Clubhouse. After that meeting, annual dues and fee amounts will be posted on our website and all payments will be accepted. We encourage all members to attend this meeting to join the discussion and vote on important issues. Thank you!
